Whereas the Council of Independent Financial Advisors (CIFA) and African Action on AIDS (AAA) both have consultative status with the UN-ECOSOC; Whereas activities of CIFA and AAA have been supporting UN sustainable development even before the adoption of the SDGs; Whereas both CIFA and AAA promote the involvement of the civil society and Private sector in the implementation, evaluation and monitoring of the SDGs, It is worth noting that on 2 February 2015 CIFA was reclassified from Special to General UN Status, with an outstanding privilege to sit at the same table with other major world players and to contribute" towards solutions of international economic, social progress and development...with a view of the creation of stability and well being which are necessary for peaceful and friendly relations between nations" (UN Charter art 55 and 71). CIFA's declaration during the last High Level Segment of ECOSOC

(UN doc - E/2016/NGO/17) definitively reaffirms its commitment to the UN Charter. With a Partner like CIFA ready to fund local activities in view of building strong evidence on successful partnerships and success stories related to the implementation of SDGs (Care for vulnerable children, Education for all, Water and sanitation in rural areas, etc...), AAA has been empowered to help a lot more people, using its mobilization skills, its network of villages and AIDS orphans.
